REGULAR BOARD MEETING  
DECEMBER 21, 2021

Meeting was called to order by Chairman Donald Schneider with Howard McCormick, Mark Turner and Christy Beckman present. Vicki Sandlin joined the meeting by zoom.

McCormick moved to approve the agenda with the addition of Wind & Solar Zoning review under new business and a work session with the attorney. Turner second, carried.
