To whom it may concern,

Overland Pass Energy, LLC (“OPE”) is applying to Sedgwick County for a Special Use Permit for the proposed construction and operations of a Utility Scale Wind System referred to as the Overland Pass Energy East Wind Project. OPE will include a maximum of up to three hundred ten (310) wind turbines located south of US Highway 76 on a portion of the “South Table,” the high plains lying south of the South Platte River Valley. OPE spans from the boundary of Logan County to the west to the boundary of Nebraska to the east and has parcels as far south as the Philips County boundary (the “Project Site”).

OPE is currently in the preliminary design stages for the project site plan. The final project layout will be designed according to numerous siting restrictions and setbacks, one of which is a strict avoidance of impact to any communication paths or microwave bands. During development, OPE has conducted two Microwave Studies to identify any potential areas of disturbance so that we can avoid any obstruction, and may conduct future studies to confirm avoidance.

This letter is a notice to all owners or licensees of microwave bands within a 2-mile buffer of our proposed project footprint, as required for the Sedgwick County permit application process. OPE is available for questions regarding the wind project via the contact information below.
