

SEDGWICK COUNTY COMMISSIONER  
REGULAR BOARD MEETING  
AUG 4, 2020

Meeting was called to order by Chairman Donald Schneider with Howard McCormick, Mark Turner and Christy Beckman and Rob Crowder present in office. Trish McClain, SCHD, Vickie Sandlin, Julesburg Advocate, Kelly Lowery, Attorney and Carl Britton joined the meeting by zoom.

McCormick moved to approve the agenda with the addition of the Quadient Leasing insurance add request, Resolution #2020-028, building permit #606 #607 and #608 under new business and possible executive session with the attorney. Turner second, carried.

Trish McClain told the Board that since there are no new cases in Sedgwick County they will continue to be monitored. Some of the problems with the delay in test results were due to using the paper procedure as opposed to online submissions.

Britton and the Board had discussion about the budget including prisoner transport, jail and vehicles. Britton left the meeting.
