Schneider moved to approve the agenda with the addition of Resolution 2024-015, and a report on CBIG. Berges second, carried.

Schneider moved to approve the Decembr 17, 2024 payables and payroll. Berges second, carried.

Berges moved to approve the December 10, 2024 minutes as amended. Schneider second, carried.

McCormick reported on the CBIG meeting. There were no other applications at the moment.
