Meeting was called to order by Chairman Donald Schneider with Howard McCormick, Mark Turner and Christy Beckman present. Vicki Sandlin, Julesburg Advocate, joined the meeting.

McCormick moved to approve the agenda with the addition of Emergency Manager Recognition under reports and Kelly Lowery under new business. Turner second, carried.

The February 27, 2020 vouchers and payroll were reviewed. McCormick moved to approve the February 27, 2020 vouchers and payroll as presented. Turner second, carried.

The minutes of the February 18, 2020 meeting were reviewed. Turner moved to approve the minutes as amended. McCormick second, carried.
