REGULAR BOARD MEETING  
JANUARY 5, 2021

Meeting was called to order by Chairman Donald Schneider with Howard McCormick, Mark Turner and Christy Beckman present. Vickie Sandlin, Julesburg Advocate, joined the meeting by zoom.

Turner moved to approve the agenda with the removal of the Treasurer's financial report and the addition of COVID task force under reports and State Grant for fairground cameras under new business. McCormick second, carried.
