REGULAR BOARD MEETING  
SEPTEMBER 14, 2021

Meeting was called to order by Chairman Donald Schneider with Howard McCormick, Mark Turner and Christy Beckman present. Dan Pederson, Accountant joined the meeting. Vickie Sandlin joined the meeting by zoom.
